Clerks Report: The Clerk gave the Clerks Report showing budget revenue, expense and the highway budget for the month.

Treasurer Report: Treasurer report was given by Shaila Anderson, Treasurer. Balance in general checking account is \$106,055.94, Money Market account, \$6,377.73 and Tax Account, \$136.48.

Road Maintenance and Highway Report: Patrolman Kirk Lehman gave the Road Maintenance Report. The crewmen have been doing general maintenance within the town. They have been mowing ditches, patching, and grading along with cutting trees in the ditches. Salt and Sand for this winter has been received.

Chairman's Report:There has been no further development on the Lysdahl tire issue. Four land use permits were issued by the County this past month. Lakeland Communication received the second grant to complete the second phase of fiber optic installation within the Town. The Town chairman is working on the LRIP grant for work done on 210th Ave this past summer.

Supervisor Comments: Supervisor Anderson and Tellijohn attended the Milltown Fire Association meeting. Supervisor Maassen attended the Cushing Fire Assn meeting. Cushing Fire Department has begun to put the footings in for their new building.

Planning Commission: No report

Citizen Comments: Paul Schneider gave a report on the Arnell Humane Program. There has been talk of eliminating the program. A decision will be made by the Polk County Environmental Committee on October 24th, 2018. The parking of a private vehicle in our parking lot was discussed. Our lot is a public lot and belongs to the elector of the Township, therefore parking is allowed.

A RESOLUTION APPOINTING THE 2018-2019 ELECTION BOARD

WHEREAS, terms of current election inspectors expire on December 31, 2017, and

WHEREAS, the town needs additional election inspectors and

WHEREAS, Wis. Stat 7.30 (4) allows the two dominant parties to submit list of names from which appointees shall be made, and

WHEREAS, the Town Chairperson is to submit a list of nominated individuals as members and alternates for approval by the Town Board; and

THEREFORE, BE IT RESOLVED that the following list of individuals be named to the 2018-2019 Election Inspectors (aka Election Board) for the Town of Eureka for the 2018 and 2019 election cycle: (January 1, 2018 thru December 31th, 2019).

BE IT FURTHER RESOLVED, that Bonnie Maassen and Mary Ostman be designated as Chief Election Inspectors; and

BE IT FURTHER RESLOVED, that, pursuant to Wis. Stats. 7.32, the minimum number of election officials required to work at the polling place during a town election is three (3); however, the town clerk has the right to choose the necessary number of inspectors from the approved election board, and

BE IT FURTHER RESOLVED, that the compensation be established at \$11.00 per hour when performing duties as Chief Election Inspectors or in training as required by Wisconsin Statutes and by the State Elections Board; and

BE IT FURTHER RESOLVED, that there are no special voting deputies appointed at this time.
