**Chairman's Report:C**hairman Krull received word that an attorney from Osceola has been given the Lysdahl tire issue. The Town Chairman has sent in the paper work for the LRIP grant for work done on 210<sup>th</sup> Ave this past summer. There were two land use permits issued by the County this past month.
