

2015 TOWN OF EUREKA TOWN CAUCUS, January 8, 2015

The 2015 Caucus for the Town of Eureka was called to order by Town Chairman Gene Krull at 6:00 pm on at the Town Hall on Thursday, January 8, 2015.

The clerk read the call of the caucus as it was posted in the four designated locations of the Town Hall, Town Garage/Clerks Office, EdgeTown Tavern, and River Roads Wolf Creek Bar on January 2, 2015. A notice was posted in the Inter-County Leader and Ledger.

Steve Jacobs/Bill Maassen **moved** to adopt the agenda; **motion carried**

A poll list was established showing eleven (22) electors of the Town were in attendance.

Caucus Tellers: Bonnie Maassen and Mary Ostman.

Town Chairman Gene Krull nominated Marvin Caspersen to take roll as Caucus Chairman. Tim Knigge/Bill Maassen **moved** to accept Marvin Caspersen as Caucus Chairman; **motion carried.**

David Anderson/Carleen Matosky **moved** to vote by paper if necessary; **motion carried**

Nomination request by ballot or vote of hands – Chairman of the caucus, Marvin Caspersen asked the voting audience how they would like to vote. David Anderson/Carleen Matosky **moved** to vote by paper if necessary; **motion carried.** All voting public decided to vote by show of paper.

Nominations for Town Chairman were opened.

Don Anderson/Paul Schneider **moved** to nominate Gene Krull. Mike Woltz/Gary Gudmunsen **moved** to nominate James Johnson. No other nominations were made. Roger Johnson/Bill Maassen **moved** to close nominations for Town Chairman; **motion carried.**

Nominations for Town Board Supervisor were opened. Tim Knigge/Dave Anderson **moved** to nominate Paul Schneider. Paul Schneider/Bill Maassen **moved** to nominate Tim Knigge. Jim Johnson/Mike Woltz **moved** to nominate Dave Peper. Gene Krull/Roger Johnson **moved** to nominate Marvin Caspersen. Dave Anderson/Mary Ostman **moved** to nominate Steve Jacobs. Marvin Caspersen/Bill Maassen **moved** to nominate Roger Johnson. No other nominations were made. Gene Krull/Roger Johnson **moved** to close nominations for Town Supervisor; **motion carried.**

Nominations for Town Treasurer were opened. Carleen Matosky/Richard Nelson **moved** to nominate David Anderson. No other nominations were made. Steve Jacobs/Richard Nelson **moved** to close nominations for Town Treasurer; **motion carried.**

Caucus Tellers preformed a paper voting for Town Supervisor. Tellers distributed ballots and tallied the ballots. Results:

Steve Jacobs = 14 votes: Tim Knigge = 11 votes: Marvin Caspersen = 10 votes: Paul Schneider = 9 votes: Roger Johnson = 8 votes: Dave Peper = 6 votes: Gene Krull write in = 1

Caucus Tellers Bonnie Maassen, Mary Ostman and Caucus Chairman Marvin Caspersen certified the Town Chairman nomination of Gene Krull and James Johnson; Town Board Supervisor nominations of Steve Jacobs, Paul Schneider, Marvin Caspersen and Tim Knigge; and Town Treasurer nomination of David Anderson for placement on the April 7, 2015, ballot.

There being no further business, Gary Gudmunsen/Bill Maassen **moved** to adjourn the meeting; **motion carried** and the meeting adjourned at 6:40 pm
