## February 13<sup>th</sup>, 2020

The regular Town Board meeting of the Town of Eureka was called to order by Chairman Don Anderson at 7:00 pm on Thursday, February 13<sup>th</sup>, 2020. Proper notice was given as the agenda was posted at the Eureka Town Hall, the Town Web Site and also published in the Tri County Advertiser.

**Tellijohn/Maassen motion** to change the agenda order and move the CAFO Ordinance and Moratorium ahead on the agenda in order to have time to talk with Andy Marshall, our attorney with our concerns before passing the resolution adopting the CAFO Ordinance and Moratorium, **motion carried**.

**Maassen/Clark motion** to approve Resolution 20-05 approving Ordinance 20-01(O) (Concentrated Animal Feed Operations), **motion carried** on a unanimous roll call vote

**Clark/Maassen motion** to approve Resolution 20-06 approving Ordinance 20-02(O) imposing a Moratorium on Issuance of CAFO Permits, **motion carried** on a unanimous roll call vote.

Chairman Anderson called for a 15-minute recess while the board thanked Andy Marshall our attorney before he left for another meeting.

Chairman Anderson called the February 13<sup>th</sup> meeting back to order.

**Clerks Report:** The Clerk gave the Clerks Reports showing budget revenue, expense and highway budget for the month of January, 2020.

**Treasurer Report:** Treasurer report as of January 31th, 2020 was given by Shaila Johnson, Town Treasurer. Balance in general checking account is \$50,307.11, Money Market Account: 26,370.32 and the tax account \$ 816,475.91.

**Road Maintenance and Highway Report:** Crewman Kirk Lehman present the Highway Report. They have been busy doing general winter maintenance, keeping the road free of ice and snow. He spent a day training our relief driver. They picked up our new ditch sprayer. They have been working clearingditches of trees and brush.

**Chairman's Report:** Chairman Anderson give an update on the meetings the board hasattended in regards to CAFO. There have been many meetings in Balsam Lake along with the Trade Lake Town

Board meetings. The new sprayer for controlling weeds in our ditches has arrived and the necessary mounting equipment has been installed. There are several meeting and seminars that the board will be attending in the next week or two.

**Planning Commission Report:**Paul Schneider said no meetings have been held since the last board meeting. The Commission has been in contact with several 4H clubs in regards to the Historical Signs located in Eureka Town. They will continue working with the 4 H clubs to restore these signs.
