The regular Town Board Meeting of the Town of Eureka was called to order by Chairperson Don Anderson at 7:03 pm on **Thursday, August 8th, 2024.**

Clerks Report: The Clerks Reports showing budget revenue, expense, and highway budget for the month of July 2024 was presented to the board.

Treasurer Report: Treasurer report as of July 30th, 2024, was given by Shaila Johnson. The balance in the general checking account is \$170,246.50, the tax account \$96,790.10 and the Savings Account \$40,019.52.

Road Maintenance and Highway Report: The crewmen have started the second round of ditch mowing. They have been working on 205th Street getting it ready for paving. There has been a lot of cleanup due to trees falling across the roads due to the heavy rains. They have been doing general maintenance, fixing washouts and graveling.

Chairperson Report: Chairperson Anderson gave the Chairperson's report. We did not receive any of the ARIP Grant money this time around. We have applied for the second round. We were served with papers for the CAFO litigation filed against us. There will be a special closed meeting on Friday night with our attorneys. We cannot discuss anything until we have met with our attorney. There was a complaint regarding a new sign posted alongside the road. Chairman will investigate it. We will be taking bids for crack sealing and chip sealing at our next meeting.

Paul Schneider gave the board information on different sprays used in ditches.
